

SHORT TERM TEAM MEMBER Liability Indemnity Agreement

THIS DEED is dated the ____ day of _____ between Destiny Rescue Charitable Trust (hereinafter referred to as "the authorised representative and organiser") and Applicant (full name) _____ (hereinafter referred to as "the team member"), of (address) _____

WHEREAS

The authorised representative and organiser has organised a project, hereinafter referred to as "the project" and the team member has entered into agreement to participate in the project on the terms and conditions hereinafter appearing.

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. The parties agree that except where it is expressly prevented at law then the team member will not in any manner whatsoever, in relation to the project, hold the authorised representative or organiser liable for any injury or damage to their persons or their properties irrespective of how such injury or damage shall occur.
2. The team member expressly acknowledges that they are involved with this project entirely and solely at their own risk and that before becoming involved they took all necessary steps and precautions to ensure that they were fully aware of any risk associated with the project and the team member confirms it is entirely their responsibility to arrange suitable travel and/or any other insurances applicable and acknowledge that they have received advice to do so from the authorised representative or organisers.
3. Each Team Member agrees to indemnify Destiny Rescue against any damage caused to a third party directly by the applicant him/herself in relation to the project.
4. Each Team Member agrees to maintain the highest standards of confidentiality with respect to any information obtained during the course of their team visit.
5. Each Team Member understands that they may be required to participate in a reference, background and police check.

SHORT TERM TEAM MEMBER Media Consent Form

Agreement between Destiny Rescue ("DR")

And _____ (the "Team member")

For the purpose of this agreement, any reference to the team member shall include all employees, companies and entities associated with team member together with all entities associated with pre & post production and distributing of any video/audio content provided or produced by team member.

1. The team member agrees to ensure that all parties associated with the filming, editing, production or distribution of any video footage, still photography or audio track produced on DR property or with DR staff or volunteers are aware of, familiar with and agree to the terms of this agreement.
2. It is understood that all video footage, still photography or audio tracks produced by the team member are and will remain the property of DR and as such cannot be sold or provided to another party without the express written consent of DR.
3. DR agrees to allow the team member to use the video footage, still photography or audio tracks for the purposes set out in this agreement only. Any variation to this agreement shall be evidenced in writing and signed by all parties.
4. The team member agrees to provide DR with a copy of ALL video, still photographs and audio tracks that are linked in any way whatsoever with DR, its properties, beneficiaries, staff or volunteers.
5. As DR is the legal owners of all such multimedia, DR reserve the right to use any such video footage, still photographs or audio tracks in any way whatsoever that DR deem fit.
6. The team member agrees to only present DR in a positive manner in all media forms used and ensure that any ensuing story that may eventuate does not directly or indirectly reflect negatively on DR or any of its operations, staff, beneficiaries or volunteers.
7. DR must sign an official approval of any finished multimedia product before it is made public. This is not for creative control but to ensure the continued safety of DR, our projects, beneficiaries, staff and volunteers.
